**RESOLUTION 2012R-661

**Designating targeted communities in the City of Minneapolis.**

Whereas, Minnesota Statutes, Section 469.202, provides that a city may by resolution designate targeted communities within its borders after adopting detailed findings that the designated communities meet the eligibility requirements in Minnesota Statutes, Section 469.202, subdivisions 2 and 3; and

Whereas, the City has documented census tracts in the City where the unemployment rate for the tract as determined by the 2010 Federal Decennial Census exceeds 13.2%, which is twice the unemployment rate for the Minneapolis and Saint Paul Standard Metropolitan Statistical Area as determined by the 2010 Federal Decennial Census; and

Whereas, the City has documented census tracts in the City where the median household income in the tract is no more than 80 percent of the median household income for the Minneapolis and Saint Paul Standard Metropolitan Statistical Area as determined by the 2010 Federal Decennial Census (less than \$52,130); and

Whereas, the City has documented census tracts in the City where 70 percent or more of the residential dwelling units in the area were built before 1960 as determined by the 2010 Federal Decennial Census; and

Whereas, the City has documented neighborhoods in the City that have a disproportionate number of vacant residential buildings and mortgage foreclosures as evidenced by a foreclosure rate of at least 1.5% in 2008; and

Whereas, the City has layered the foregoing designated areas to create a map that identifies the portions of the City that meet at least three of the four foregoing criteria (the "Core Area"); and

Whereas, Minnesota Statutes, Section 469.202, subdivision 3, permits the City to add to the qualifying area additional area extending up to four contiguous city blocks in all directions from the Core Area;

Now, Therefore, Be It Resolved by The City Council of The City of Minneapolis:

That based on the foregoing findings and strategic additions of up to four contiguous city blocks in certain directions, the City of Minneapolis hereby designates the map contained in Petn No. 2076206 on file in the office of the City Clerk as the map of designated Targeted Communities within the City of Minneapolis consistent with Minnesota Statutes, Section 469.202.

**RESOLUTION 2012R-665**

**By Glidden**

**Approving License Settlement Conference recommendations relating to the On-Sale Liquor Class C-1 with Sunday Sales License held by Red Sea Bar and Restaurant, 320 Cedar Ave S.**

Whereas, the Licenses & Consumer Services Division held a License Settlement Conference hearing on November 1, 2012 with the licensee; and

Whereas, the Regulatory, Energy & Environment Committee received Findings of Fact, Conclusions and Recommendations that concluded that the licensee violated the Minneapolis Code of Ordinances, as follows:

a) On October 27, 2012, the licensee violated Section 362.30 of the Code for engaging in activities defined under Class B Entertainment without a license; and

b) On October 27, 2012 the licensee failed to comply with all applicable laws and ordinances of Section 259.250 (2) of the Code governing Business License Management Responsibilities;

Now, Therefore, Be It Resolved by The City Council of The City of Minneapolis:

That the following recommendations be adopted, as more fully set forth in said Findings on file in the Office of the City Clerk and made a part of this report by reference:

1. The licensee shall remit to Licensing & Consumer Services within one week of signage of this document the sum of \$2,000 (a doubling of the last citation issued) for engaging in activities on October 27, 2012 defined under Class B Entertainment without the benefit of a license and after being ordered to cease and after being cited twice previously for the same offense. \$1,000 of this citation penalty will be stayed for a period of one year if there are no repeat violations.

2. The Red Sea shall, in addition to meeting the security conditions included within, take all necessary and prudent steps to avoid violent incidents from occurring at their events by assessing the reasonably foreseeable risks associated with the nature of the event, the history of the performer, and the number of anticipated attendees. Such necessary and prudent steps shall include, at a minimum:

- a) Employing uniformed, armed officers or security for the event.
- b) Not holding the event.

3. When employing uniformed, armed officers or security for an event, glass bottles will not be served to patrons.

4. When employing uniformed, armed officers or security for an event, no one under the age of 21 will be allowed to enter the premises.

5. The licensee shall e-mail their event schedule and advertisements to the Minneapolis Police 1st Precinct and Business Licensing every two weeks for one year following approval of this agreement.

6. To assist in the prevention of reoccurring disturbances by known persons, the licensee shall compile, maintain and share with the 1st Precinct a "Do Not Admit" list of persons who have been trespassed and/or refused service per Minnesota Administrative Rule 7515.0590, Subparagraph 3.

7. The licensee must utilize an ID scanner to verify the age of all persons seeking to gain entrance to the establishment.

8. The licensee will be responsible for the confiscation of falsified identification cards and the timely remittance of these cards to the 1st Precinct.

9. A staff person shall be assigned as the "controller" with the duties to oversee the amount of alcohol being served to reduce the potential of over serving.

10. Dedicated security staff will monitor the activity in the establishment, and if any criminal activity is observed, security must escort the customer(s) from the premises. Staff will request Minneapolis Police assistance for any violent event or injury.

11. Dedicated security staff shall not allow customers or passersby to loiter near the establishment during business hours. Patrons smoking outside will not be considered a violation of this condition.

12. The licensee shall utilize the closing procedure as detailed in the business plan and security plan.

13. Dedicated security staff shall assist in crowd dispersal for at least one half hour after closing of the establishment to prevent loitering.

14. The licensee will not distribute hand-bills advertising promotions to anyone walking on City sidewalks, streets, or alleys; nor place advertising on parked motor vehicles or any public space or building or private building without written consent of the owner.

15. The licensee shall develop and utilize a promoter contract for any event in which a promoter is used and provide a copy of the contract to the Licensing Office. The contract will contain language stating that no promoter shall post any materials (snipe advertising) in violation of Minneapolis Ordinances.

16. The licensee shall send a representative to the monthly LINC meetings.

17. The licensee shall contact the 1st Precinct SAFE Team to request an outside security lighting assessment and implement their suggestions to the establishment prior to February 28, 2013.

18. The licensee shall operate and maintain surveillance cameras in accordance with Minneapolis City Ordinance 259.230 for all areas accessible to the public.

19. The licensee shall submit an amended and enhanced business and security plan.

20. Upon the signing of the aforementioned conditions, Licenses & Consumer Services shall recommend to the City Council that the Red Sea Bar and Restaurant be granted an upgrade to a Class B On-Sale Liquor License.

**Approving Business License Operating Conditions relating to the Motor Vehicle Repair Garage License held by Ahmed's Certified Auto Care, 616 45th Ave N.**

Resolved by The City Council of The City of Minneapolis:

That it approves the following Business License Operating Conditions relating to the Motor Vehicle Repair Garage License held by Ahmed's Certified Auto Care, 616 45th Ave N:

1. The business shall not store inoperable vehicles or any vehicle parts outside of the enclosed service garage.
2. The business shall adhere to Minneapolis Code of Ordinance 317.160 (e) that states the use of the City right-of-way to park, store, or repair customer motor vehicles is cause for adverse license action.
3. The business shall maintain records which include all work orders, estimates, invoices, and names of all customers for whom motor vehicle repairs have been performed.
4. Refuse shall be stored in a regularly serviced, closed container (dumpster) that shall be maintained screened from view as is required by Minneapolis Codes. At no time shall this refuse container be overfilled so that the cover cannot be completely closed at all times.

**Amending Title 20, Chapter 520 of the Minneapolis Code of Ordinances relating to *Zoning Code: Introductory Provisions*.**

The City Council of the City of Minneapolis do ordain as follows:

Section 1. That Section 520.160 of the above-entitled ordinance be amended by adding thereto the following definitions in alphabetical sequence to read as follows:

**520.160. Definitions.** Unless otherwise expressly stated, or unless the context clearly indicates a different meaning, the words and phrases in the following list of definitions shall, for the purposes of this zoning ordinance, have the meanings indicated. Additional definitions may be found within specific chapters of this zoning ordinance. All words and phrases not defined shall have their common meaning.

Daily living skills. Personal management and social skills, including but not limited to home care maintenance, food preparation, personal care, money management, and child rearing skills, that are necessary for adequate functioning on an independent basis.

Supportive housing. A facility that provides housing for twenty-four (24) hours per day and requires participation by residents in programs or services designed to assist residents with improving daily living skills, securing employment or obtaining permanent housing. It does not include:

- (1) Senior housing with services designed specifically to serve the needs associated with the aging of the residents.
- (2) Inebriate housing.
- (3) Any facility licensed by the Minnesota Department of Human Services (DHS), Department of Health (DOH) or Minnesota Department of Corrections (DOC).
- (4) Any other county, state or federal community correctional facility.
- (5) Fraternities, sororities or other student housing.
- (6) Any facility owned, leased or operated by the Minneapolis Public Housing Authority (MPHA).
- (7) The use of one (1) dwelling unit on one (1) zoning lot which meets the occupancy requirements of the zoning district in which it is located.

**Amending Title 20, Chapter 536 of the Minneapolis Code of Ordinances relating to Zoning Code: Specific Development Standards.**

The City Council of the City of Minneapolis do ordain as follows:

Section 1. That Section 536.20 of the above-entitled ordinance be amended by amending the following specific development standard in alphabetical sequence to read as follows:

**536.20. Specific development standards.** The uses listed below are subject to the following specific development standards, in addition to all other applicable regulations:

*Supportive housing.*

(1) Supportive housing shall be located at least one-fourth ( $\frac{1}{4}$ ) mile from all existing supportive housing and from all of the following uses, except in the B4H Overlay District:

- a. Community correctional facility.
- b. Community residential facility.
- c. Inebriate housing.
- d. Motel.
- e. Overnight shelter.

~~(2) The maximum number of persons served shall not exceed thirty-two (32), except in the B4H Overlay District.~~

- (32) On-site services shall be for residents of the facility only, except where part of a regimen of scheduled post-residential treatment.
- (43) To the extent practical, all new construction or additions to existing buildings shall be compatible with the scale and character of the surroundings, and exterior building materials shall be harmonious with other buildings in the neighborhood.
- (54) An appropriate transition area between the use and adjacent property shall be provided by landscaping, screening, and other site improvements consistent with the character of the neighborhood.
- (65) The operator shall submit a management plan for the facility and a floor plan showing sleeping areas, emergency exits and bathrooms.

Adopted.

**Z&P** - Your Committee, having under consideration the appeal filed by Bianca Fine, on behalf of Currie Park Development, LLC, from the decision of the Heritage Preservation Commission denying the demolition of historic resource application for Gluek Brewing Tied House, 1500 6th St S, now recommends that the appeal be granted in part to move the building to 1527 6th St, as defined in Section 599.110 of the Minneapolis Code of Ordinances, but not to raze the building. #### **RESOLUTION 2012R-673**

**Recognizing the 150<sup>th</sup> Anniversary of the Dakota-U.S. War of 1862 and Declaring 2012-2013 the Year of the Dakota in Minneapolis.**

Whereas, the year 2012 is the sesquicentennial of the beginning of the Dakota-U.S. War of 1862 that led to the mass execution of 38 Dakota, the largest in the history of the United States, and the genocide of the Dakota people; and

Whereas, much has yet to be learned about issues revolving around land, reparations and restitution, treaties, genocide, suppression of American Indian spirituality and ceremonies, suppression of Indigenous languages, bounties, concentration camps, forced marches, mass executions, and forcible removals; and

Whereas, Indigenous women, children and elderly were held in a concentration camp at the base of Fort Snelling, separated from the men, before being exiled to reservations in neighboring states and Canada, and later being stripped of their culture and traditions in boarding schools and subjected to white culture and religions; and

Whereas, the complete history of Minnesota must be taught from the perspective of all people that have lived it;

Now, Therefore, Be It Resolved by the City Council of The City of Minneapolis:

That every effort must be made to ensure that the Dakota perspective is presented during the year 2012-2013, through discussions at forums, events, symposia, conferences and workshops, to include the complex issues listed above;

Be It Further Resolved that the City of Minneapolis works to promote the well-being and growth of the American Indian community, including Dakota People.

Be It Further Resolved that these efforts during the years 2012 and 2013 will mark the beginning of future dialogues and efforts to rectify the wrongs that were perpetrated during, and since, the year 1862, a tragic and traumatic event for the Dakota People of Minnesota.

Be It Further Resolved that the year 2012-2013 is hereby designated "The Year of the Dakota: Remembering, Honoring, and Truth-Telling," from December 26, 2012 to December 26, 2013.
