## Recognizing 2020 Census Kick Off.

Whereas, the U.S. Census Bureau is required by Article I, Section 2 of the U.S. Constitution to conduct an accurate count of the population every ten years; and

Whereas, the next enumeration will be April 1, 2020, and will be the first to rely heavily on online responses; and

Whereas, these diverse communities and demographic populations are at risk of being missed in the 2020 Census; and

Whereas, a complete and accurate count of Minneapolis's population is essential; and

Whereas, the data collected by the decennial Census determines the number of seats each state has in the U.S. House of Representatives and is used to distribute billions of dollars in federal funds to state and local governments; and

Whereas, the data is also used in the redistricting of state legislatures, county boards of supervisors and city councils; and

Whereas, the decennial census is a massive undertaking that requires cross-sector collaboration and partnerships in order to achieve a complete and accurate count; and

Whereas, the theme of the Minneapolis US Census campaign is "We Count"; and

Whereas, Minneapolis leaders have dedicated funding and resources to ensure every Minneapolis resident is counted; and

Whereas, Minneapolis is kicking-off its outreach and engagement efforts on April 1, 2019, for the 2020 Census; and

Whereas, Minneapolis, in partnership with other local governments, the State, businesses, schools, and community organizations, is committed to robust outreach and communication strategies, focusing on reaching the historically undercounted individuals;

Now, Therefore, Be It Resolved by The City Council of The City of Minneapolis:

That the City of Minneapolis recognizes the importance of the 2020 U.S. Census and acknowledges April 1, 2019, as the Kick Off for our city's efforts to ensure a complete, fair, and accurate count.

Goodman offered Ordinance 2019-015 amending Title 12, Chapter 244 of the Minneapolis Code of Ordinances relating to Housing: Maintenance Code, amending the rental license expiration date and fees.

Amending Title 12, Chapter 244 of the Minneapolis Code of Ordinances relating to Housing: Maintenance Code.

The City Council of the City of Minneapolis do ordain as follows:

Section 1. That Section 244.1860 of the above-entitled ordinance be amended to read as follows:

**244.1860.** Expiration; renewal. All licenses and provisional licenses issued under this article shall expire on August thirty-first of each year annually, subject to renewal year to year in the manner provided in this article. All licensees and provisional licensees shall apply for renewal of their licenses on a form provided by the director of regulatory services. The renewal application may be in such abbreviated form as deemed sufficient by the director to verify current information on file concerning the licensee. No license or provisional license shall be granted without payment of the required annual license fee. An individual who is operating a rental dwelling after the license has expired is operating an unlicensed rental dwelling.

Section 2. That Section 244.1880 of the above-entitled ordinance be amended to read as follows:

**244.1880.** License fees. (a) Effective July 1, 2015: The annual license fee for a rental dwelling license or provisional license shall be as set out in the tiered rental license fee found in Appendix J and shall be applied to the first unit. The annual license fee shall be five dollars (\$5.00) for each additional dwelling unit under common ownership in the same building. A change in ownership shall require a new license

application and payment of the license fee. An increase in the number of licensed dwelling units during the license year shall require an amended license application and the payment of an additional license fee to cover the additional units.

- (b) The annual license fee shall be increased by twenty-five (25) percent when more than fifteen (15) calendar days late. Late applicants shall not be entitled to prorated license fees. When more than forty-five (45) days late, the annual license fee shall be additionally increased by twenty-five (25) percent.
- (c) License fees shall be prorated as follows:
- (1) Issued during first half of license year\Full fee.
- (2) Issued during second half of license year\1/2 fee.

Amending Title 17, Chapter 440 of the Minneapolis Code of Ordinances relating to Streets and Sidewalks: City-Owned Plazas.

The City Council of the City of Minneapolis do ordain as follows:

Section 1. That Chapter 440 of the Minneapolis Code of Ordinances be amended by adding thereto an Article I, to include Sections 440.10 and 440.20; and amending Section 440.10 to read as follows:

## **ARTICLE I. – GENERALLY**

- **440.10. Prohibited conduct without permit.** No person shall use <del>Peavey Plaza,</del> Riverfront Plaza, Cedar-Riverside Plaza, Loring Greenway, <del>Nicollet Mall</del> or any other plaza-like area owned by the City of Minneapolis <u>except for Peavey Plaza</u> for any concert, exhibition, commercial venture, organized play or picnic activities, or for any similar purposes, without first obtaining a permit from the city council under this chapter.
- **440.20. Permit applications.** Any applicant for a permit under this chapter shall file an application, on forms provided by the director of public works, who shall review the application and make whatever investigation he or she deems necessary. Among other factors the director of public works should consider in making a recommendation is whether liability insurance should be required, and if so, how much, and whether a bond should be required, and if so, how much. The director of public works shall then make a determination as to whether to issue a permit and as to what conditions, if any, should attach to the permit. In the event the director of public works determines that a permit shall not be issued, the director of public works shall report back to the city council, which shall then make its own determination.

Section 2. That Chapter 440 of the Minneapolis Code of Ordinances be amended by adding thereto a new Article II, including new Sections 440.50 through 440.120, to read as follows:

## <u>ARTICLE II. – PEAVEY PLAZA</u>

- 440.50. Peavey Plaza defined. Peavey Plaza shall mean the area in the City of Minneapolis at the south end of Nicollet Mall east of the Mall, between 11th Street South and 12th Street South. Peavey Plaza serves as a public amenity for passive recreation, gatherings, organized events and other plaza-like purposes, and is considered a public forum for First Amendment purposes.
- **440.60.** Conformance with governing policy. Except as limited by the provisions of this chapter, rules governing conduct in Peavey Plaza may be adopted and amended from time to time by the Chair of the Downtown Public Asset Committee. "Rules of Peavey Plaza" as used in this chapter shall mean the city's written rules approved by and kept on file with the Chair of the Downtown Public Asset Committee.
- **440.70. Peavey Plaza operator.** The city may, by written contract, designate a not-for-profit organization to carry out the operation and maintenance of Peavey Plaza. Any such contract must be approved by action of the city council. "Operator" as used in this chapter shall mean any organization falling under the provisions of this section.
- **440.80. - 440.90. Control of public space. Permits may be issued pursuant to this ordinance by either the Chair of the Downtown Public Asset Committee or through contract with an Operator consistent with permitting terms approved by the Chair of the Downtown Public Asset Committee. Permits issued pursuant to this chapter shall not operate so as to transfer ownership or control of Peavey Plaza to permittees, or to any other party.

The consumption of alcohol in Peavey Plaza shall be governed by Title 14, Chapter 364, and any applicable rules of Peavey Plaza.

**440.100. - Compliance with laws.** Persons or entities visiting Peavey Plaza shall comply with all applicable federal, state, and local laws as they may be amended from time to time.

**440.110 - Enforcement.** In addition to any other remedy available at equity or law, failure to comply with the provisions of Title 14, Chapter 364, or this Chapter 440, including but not limited to the governing policy referenced herein, may result in criminal prosecution, administrative fines, restrictions, or penalties as provided in Chapter 2 of this Code. The provisions of this chapter shall not limit or impair the statutory or common law right of the city or its authorized officers, agents, or officials to make arrests or issue citations for violations of applicable laws or ordinances.

Whereas, the City intends to advance funds from its Self-Insurance Fund (or another fund chosen by the City's Finance Officer) in order to redeem and prepay the outstanding Refunded Bonds and proposes to designate such advance as an interfund loan in accordance with the terms of this resolution; and

Be It Further Resolved that payments of principal of and interest (the "Payments") on the Interfund Loan shall be paid semiannually on each March 1 and September 1 (each a "Payment Date"), commencing on September 1, 2019, and continuing until the principal of and interest on the Interfund Loan is paid in full.
