

ORDER BY THE MUNICIPAL CANVASSING BOARD CITY OF MINNEAPOLIS

We, the legally constituted municipal canvassing board of and for the City of Minneapolis, pursuant to the provisions of Minnesota Statutes § 205.185, subd. 3 and Minnesota Statutes § 204C.36, subd. 2, having convened this first day of December, 2017, do hereby certify that: (1) on November 15, 2017, we specified the names of the persons receiving the votes and the number of votes received for the Ward 6 (City Council) race voted upon at the General Election held Tuesday, November 7, 2017, in the City of Minneapolis; (2)upon proper request by a candidate for the Ward 6 (City Council) race, a partial recount was conducted on Tuesday, November 28, 2017, involving three of the nine precincts, resulting in amended results based on a physical hand-count and examination of eligible ballots, with the recount results differing slightly from results originally certified on Wednesday, November 15, 2017; and (3) the revised official results of the Ward 6 (City Council) race appear by the returns of the election precincts voting in this specific race, duly returned to, filed, opened, and canvassed, and now remaining on file in the Office of City Clerk, City of Minneapolis. Further, we direct the City Clerk to submit a certified copy of the official results of the 2017 Municipal (Ward 6) Election to the Hennepin County Auditor and to file and preserve the original returns and all election records for the Ward 6 race in accordance with Minnesota Election Law.
