Alcohol Server Training: The Sonder Shaker has contracted with ALE Training to do their alcohol server training. They will commence training prior to the business opening. Alcohol compliance training will be given to pertinent employees on at least an annual basis by a qualified outside training provider. Employees will be required to check for proper identification from all patrons who appear to be under the age of 30 ordering or being served alcohol. All staff will be trained to not admit or serve intoxicated persons. The business will conduct self-audits to ensure compliance. If an employee fails a Youth Alcohol Compliance check they will be terminated immediately. They will strictly enforce their plan.

Applicant

The applicant is Limelight Concepts, LLC., a Minnesota company formed on September 27, 2016. They are registered under chapter 322C, File #903481300028 of the Minnesota statutes. The applicant has provided documentation showing adequate, legal, and traceable funding for this venture. They have the required stock restriction on the transfer of shares and have the following shareholders and officers:

Manager

Cassidy Flannery will be the manager of The Sonder Shaker. He has five years of experience in the hospitality industry. He was a bartender at Waterfront Tavern in LaCrosse, WI, from 2009-2014. He was then employed by Target Corporation from 2014-2016 starting in procurement and worked his way up to Senior Specialist. He is currently employed as a Consultant with Dahl Consulting.

Premises

The premises will be located at 130 East Hennepin Avenue. It is a newly constructed eight-story building. The business will operate in 2,501 square feet of space on the first floor. They will have 77 indoor seats for patrons. There will also be a 14 seat sidewalk café. The building that will house The Sonder Shaker is still under construction and the sidewalk is not complete, therefore, the sidewalk plan cannot be approved by Minneapolis Public Works until the sidewalk is complete. We are seeking approval of the sidewalk café upon completion of inspection.

Business Plan/Operations

The Sonder Shaker will be a full-service sit down restaurant. They will offer a variety of entrees, including lobster roll, cuban, and fried chicken sandwiches. They will also have a variety of snacks as appetizers. The hours of operation will be 12:00 p.m.-12:00 a.m. Monday-Thursday; 12:00 p.m.-1:00 a.m. Friday; 11:00 a.m.-1:00 a.m. Saturday; and 11:00 a.m.-8:00 p.m. Sunday. The business will require that all servers attend alcohol server training. They will also be required to attend annual training. Their plan indicates that all patrons will

be required to provide proper identification to verify their age. Noise mitigation will also be emphasized to their employees to address loud and unruly patrons. There will be strong emphasis on patrons leaving the business at closing time. The Sonder Shaker is requesting an On-Sale Liquor with Sunday Sales Class "E" license. Under this license class live entertainment is not permitted.

Public Hearing Summary

A public hearing for this license application will be held on October 24, 2017, in City Council Chambers, Room 317. Public hearing notices were mailed to residents and property owners within 600 feet of the premises. An electronic hearing notice was e-mailed to Council Member Jacob Frey, Nicollet Island-East Bank Neighborhood Association, Historic Northeast Business Association.

Recommendation

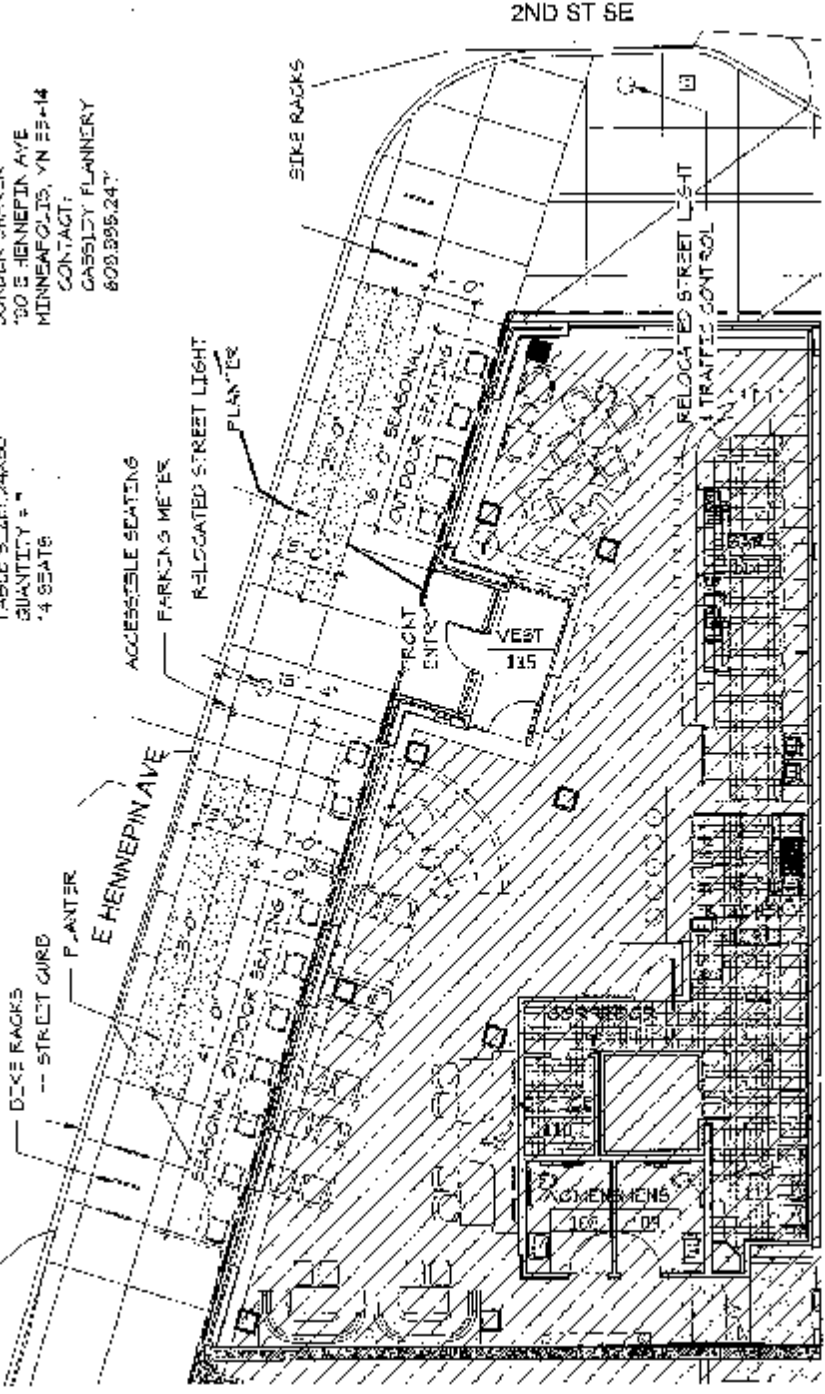
Licenses and Consumer Services Division recommends the approval of an On-Sale Liquor with Sunday Sales, Class "E" license.
