1. There shall be no "all you can drink" specials offered at this establishment.
2. The licensee shall offer full restaurant service, with kitchen staff, during all hours of operation.
3. The licensee shall not distribute hand-bills advertising to anyone walking on city sidewalks, streets, or alleys, nor place any on parked motor vehicles.
4. The licensee shall at all times keep an accurate occupancy count and immediately share such figures upon the request to any official of the City of Minneapolis.
5. The licensee shall comply with the Surveillance Camera Ordinance Section 259.230 of the Minneapolis Code of Ordinances. The licensee will install camera coverage for the exterior premises as determined by the Manager of Licenses and Consumer Services. The surveillance camera shall be in operating order at all times.
6. To assist in the prevention of reoccurring disturbances by known persons, the licensee shall compile, maintain and share with the local Police Precinct a "Do Not Admit/86" list of persons who have been trespassed and/or refused service.
7. The licensee shall follow the terms of the business plan, menu, and security plan as submitted with the license application. Should it become necessary, the licensee shall meet with representatives of the City of Minneapolis to discuss safety, security or operational concerns and make changes to the plans as deemed appropriate.
8. The licensee shall take all necessary and prudent steps to avoid violent incidents from occurring at their establishment by assessing customers' behaviors and removing any

customer who acts in a belligerent, loud or otherwise disruptive manner. If any criminal activity is observed, security must escort the customer from the premises and request Minneapolis Police assistance.

9. The licensee shall take all necessary and prudent steps to avoid violent incidents from occurring at their establishment during events by assessing the reasonably foreseeable risks associated with the nature of the event(s), the history of the performer(s), and the anticipated number of attendees.
10. The licensee shall employ a manager, an assistant manager, or supervisory-level employee at all times the business is open to the public.
11. The licensee shall perform a criminal background check on any new employee and maintain a copy of the employee's identification and background check on the licensed premises. This documentation shall be made available to City staff upon request.
12. No person who appears to be obviously intoxicated will be allowed to enter the establishment.
13. The licensee shall provide a full and up to date schedule of events on their public website that details each event or promotion the establishment is offering and also includes their food menu offerings with food service times.
14. The licensee must utilize an electronic ID scanner to verify the age of all persons seeking to gain entrance to the establishment after 11:00 PM.
15. Dedicated security staff shall assist in crowd dispersal for at least one half hour after closing of the establishment to prevent loitering.
16. The licensee shall send a representative to monthly LINC meetings.

I have read and understand the conditions listed above. I agree with the conditions and understand that failure on our part or on the part of my company or employees to adhere to these conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the LIC373784 Urban Entertainment LLC license. It is understood and agreed upon that these license operating conditions shall remain enforceable and in full force and effect throughout the applicable license term, inclusive of any subsequent license

renewals, until and unless modified, amended, or canceled by appropriate action of the Minneapolis City Council.
